# Dr. Lina Digolo- Nyagah

Dr. Lina Digolo is a pediatrician and clinical epidemiologist with over 17 years of experience as a technical expert in health system strengthening, research, policy development, and service delivery. She has a strong interest in bridging the gap between research evidence and practical implementation.

Lina possesses extensive expertise in assisting national governments, civil society organizations, bilateral and philanthropic donors, and UN agencies in utilizing evidence for policymaking and designing programs, primarily in the Global South. She has conducted several studies on violence against women and children in Kenya, most of which have been pivotal in shaping policy and service delivery guidelines in the region.

Lina has actively contributed to developing, reviewing, and disseminating various regional and international policies and guidelines related to the prevention of violence against children and women.



#### **Prof. Olive Shisana**

Prof. Shisana is the Social Policy Special Advisor to the President of South Africa engaging in many different areas including GBV, health, COVID-19, education, and social development.

She previously served as the first Director-General in the South African Department of Health, Principal Investigator in several national population-based HIV surveys, President of the International Social Science Council, and Chief Executive Officer of the Human Sciences Research Council. Prof. Shisana served as the co-chair of the Interim Steering Committee on Gender-Based Violence and Femicide in SA.

Prof. Shisana holds a Doctor of Science degree from the Johns Hopkins University and was awarded the highest national order, the South African Order of Baobab in Bronze offered by the President: "For her outstanding contribution to the field of science and community service, particularly her tireless work in researching solutions to the scourges of HIV and AIDS." She is an honorary professor at the University of Cape Town and was awarded the Doctor of Laws honoris causa degree by Monash University.



### Ms. Chi-Chi Undie

Chi-Chi Undie is a Senior Associate and Technical Director with the Population Council's International Programs Division. Her research focuses primarily on sexual and gender-based violence (SGBV) and girls' education. For a decade, she directed the 'Africa Regional SGBV Network'— an SGBV response, research, and research uptake initiative in the East, Horn, Great Lakes, and Southern regions of Africa. Her research and evidence-informed advocacy efforts have influenced policy and programming in the region.

She is the inaugural Board Chair of the Sexual Violence Research Initiative, and a Together for Girls Board Member. She currently directs two five-year, regional, FCDO-funded research consortia - one centered on SRHR in refugee settings, and the other on FGM/C.



## Ms. Lusungu Kalanga

Lusungu is currently a GBV Principal Consultant for Social Development Direct, serves as the GBV Regional Advocacy Lead for Southern & Eastern Africa for the global "What Works to Prevent VAWG programme" and sits on various international women's rights initiatives & organisations' boards.

She is the Co-Founder of "Feministing While African", an online community of over 260 African feminists, and co-founded the Malawi Feminists and Allies, a collective of Malawian feminists and organizations that advocates for women's rights and social justice. She is the co-creator and co-host of Feministing While Malawian podcast, named one of the best podcasts in Africa by The Guardian.

Lusungu has received various awards and recognition for her work; including being selected as one of the 25 outstanding young African women leaders by the Moremi Initiative for Leadership Empowerment and Development. She is an Obama Foundation leader in Africa (2019) and a Mandela Washington Fellow (2016).



## Ms. Kealeboga Kelly Dambuza

Kelly is the Gender Based Violence Portfolio Manager at the Southern African Development Community (SADC) Secretariat. She is currently leading the implementation of the SADC Strategy and Framework of Action for Addressing GBV (2018-2030).

Having worked for SADC, the government and the United Nations, she has over 15 years of extensive experience in the area of Gender Based Violence, including addressing related sexual and reproductive health and HIV and AIDS issues. In Botswana she also led the implementation of the first ever national study on GBV and the development of the first National Strategy on addressing GBV.


Through her extensive experience, she has gained a deep understanding of both the profound vulnerability and remarkable resilience exhibited by women throughout the continent.


#### Ms. Anna Augla




# Dr Thandi van Heyningen
